*Grant Application Guidelines*

Please review the following guidelines prior to submitting a grant application:

- Only shelter-related registered charities operating in the province of Manitoba are eligible.
- Organizations must demonstrate sound fiscal responsibility and effective management.
- All applications should be received annually by September 15

*Funding Restrictions*

Grants will not normally be considered for the following types of organizations:

- Medical institutions
- Camps
- Theatre or performing arts groups
- Private foundations
- Service or fraternal clubs
- Religious institutions
- Agencies/organizations which raise funds for distribution to other community organizations

The foundation will not fund budget deficits; activities completed, or costs incurred prior to the current year of application; political activities; fundraising events; or endowments.

The organization applying for the grant must have been in continuous operation delivering services in Manitoba for a minimum of two fiscal years prior to the date of the grant application submission.

*Application Process*

Grant decisions are generally made once each year in October. Successful grant applicants will be informed of the amount of the grant within approximately one month following grant decisions.

Grantees are asked to complete and return the terms of grant agreement document which will be provided to them upon the successful granting of their funding request.

Manitoba REALTORS® Shelter Foundation may receive submissions for a large number of organizations each year and the funds available will generally enable assistance to only a portion of these. An unfavourable decision from the foundation in no way reflects the quality of the organization making the request, nor the need for the funds. We thank you for considering Manitoba REALTORS® Shelter Foundation to help support your cause.
